The fee shall be \$50.00 per annum for limousine or livery operated in the township and an applicant fee in the amount of \$25.00.

Any vehicle listed on this application must be owned by the registered owner in order to operate under the license issued. Applicant, whether an individual, member of a partnership, or those holding office in a corporation, must submit fingerprint Based Criminal Background Check. Applications by partnership shall give the information for each partner and shall be verified by all partner(s). Application(s) by corporation(s) shall give the information required for and be verified by all officer(s) and director(s) and all person(s) holding more than ten percent (10%) of the corporation's common stocks as well as the corporation itself.

Application must be accompanied by a full-color sketch showing the color scheme of the limousine or livery service motor vehicle(s) to be operated by the applicant and another full-color sketch of any insignia or design which the applicant intends to use as identification for its motor vehicle. It must also supply evidence as to the applicant's business financial responsibility.

All licenses shall be liable to suspension or revocation for any violation of this article or the laws of the State of New Jersey. Omnibuses, limousines, and liveries shall be carefully operated and consistent with all motor vehicle laws of the State of New Jersey and Township of Hillside ordinances.

The Police Department shall have the right to see to it that all vehicles falling under the scope of this article are kept in a condition of safety and sanitation and to that end shall have the right at any and all times to inspect or cause to be inspected such licensed vehicles and shall maintain a record, in writing, of the report of all such inspections.

All applicant(s) must provide a copy of the municipal license or certificate issued by the municipality where the service is principally located and a power of attorney appointing the Director of the Division of Motor Vehicles their true and lawful attorney for the acceptance of service of process. The copy of the municipal license, or an attached insurance certification, shall include the name of the insurance company, the number and date of expiration of the policy, and a description of all vehicles covered under the policy. **Liability coverage must be for \$1.5 million.**

The license shall be authorized by the Township Council and signed by the Township Clerk.
