2025 ANNUAL MEETING SCHEDULE

WHEREAS, in accordance with the provision of N.J.S.A. 10:4-18, at least once a year, within seven days following its annual reorganization meeting, the Township Council is obligated to provide "adequate notice", as defined in N.J.S.A. 10:4-8(d), of the schedule of the regular meetings of the Township Council to be held during the succeeding year; and

WHEREAS, the Township Council desires to establish a meeting schedule for the year (January 1, 2025, through December 31, 2025), as required by the New Jersey Open Public Meetings Act.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Hillside, as follows:

During the period of January 1, 2025, through December 31, 2025, unless otherwise indicated below*, the Township Council shall have (1) Annual Reorganization Meeting (1) Caucus Meeting per month and (1) Caucus-Regular Meeting per month. The dates and times for such meetings are set forth in the Meeting Schedule Notice below. Unless otherwise notified, all Caucus Meetings, Caucus-Regular Meetings, and the Reorganization Meeting of the Township Council shall be held at 6:30 p.m. at the Township Municipal Building, 1409 Liberty Avenue (Liberty and Hillside Avenues), Hillside, NJ 07205. All meetings will take place on Tuesdays.
