

## **TOWNSHIP OF HILLSIDE GARAGE SALE RULES & REGULATIONS**

**SECTION I. “Chapter VII (Licensing General) of the Revised General Ordinances the Township of Hillside, 1971” is hereby amended:**

**7-7.2** It shall be unlawful for any person to conduct a garage sale in the Township of Hillside without first filing with the Building Officer the information hereinafter specified and obtaining from such Building Officer a license so to do, to be known as “Garage Sale License.” The fee for such shall be, and the same is hereby fixed at five (\$5.00) dollars.

Only three (3) such licenses shall be issued to any one person or family occupying the same premises during any one calendar year and no such license shall be issued for more than three (3) consecutive days. The Building Officer shall in the event of rain on any of the three days, at the request of the applicant, grant additional days for a “garage sale” which additional days shall not exceed two (2). No second or third license shall be issued within the period beginning on the date of the last day of the garage sale and thence running sixty (60) days therefrom.

Section 22-7.10 (1) of the “Revised General Ordinances of the Township of Hillside” (Chapter XXII, Zoning):

**“Garage Sales”** – The display of any sign stating that there is a “Garage Sale” or any other words indicating that there will be a garage sale is prohibited unless the following standards are complied with:

1. Signs shall not exceed ten (10) inches by fourteen (14) inches in area.
2. Signs shall consist of black lettering on a white background, which shall state only that there is a “Garage Sale”.
3. The sign must be removed immediately after the garage sale is over.
4. The sign can only be placed on the property where the garage sale is taking place and not other areas.
5. The sign shall have a setback of at least fifteen (15) feet from all streets.

**GARAGE SALE SIGNS ARE NOT TO BE POSTED ON TREES OR TELEPHONE POLES OR ANY OTHER POLES.**

**FAILURE TO COMPLY WITH THE ABOVE RULES AND REGULATIONS WILL SUBJECT YOU TO A PENALTY.**
