WHEREAS, Associated Humane Societies, Inc., located at 124 Evergreen Avenue, Newark, New Jersey 07114, is a 501(c)(3) nonprofit organization that provides animal control services in compliance with the rules and regulations of the New Jersey Department of Health, Office of Veterinary Health; and

WHEREAS, because the contractor is a nonprofit organization prohibited from making political contributions, the contract is exempt from the "Fair and Open" process, and may be awarded as a Non-Fair and Open contract pursuant to applicable law; and

**WHEREAS**, the proposed contract amount is not to exceed \$119,175.00, which exceeds \$17,500, requiring approval by resolution of the Township Council; and

WHEREAS, the Township Council finds it to be in the best interest of the Township to enter into a contract with Associated Humane Societies, Inc. for the provision of comprehensive animal control services as set forth in the Animal Control Services Agreement.

# NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HILLSIDE THAT:

- 1. The Township of Hillside is hereby authorized to enter into a Non-Fair and Open Contract with Associated Humane Societies, Inc. for animal control services for the term of January 1, 2026 through December 31, 2026.
- 2. The total proposed contract amount is not to exceed \$119,175.00 contract amount as set forth in the agreement, payable in accordance with the contract terms.
- 3. A copy of this Resolution and the fully executed contract shall be placed on file.

### **Animal Control Services Agreement**

collectively the "Parties."							

**WHEREAS**, the state of New Jersey requires each municipality to provide animal control services or to contract for the provision of such services;

WHEREAS, animal control services are important to communities in a variety of ways including rescuing animals in distress, reuniting lost pets and their families, responding to nuisance complaints, et cetera;

WHEREAS, the Society is dedicated to providing animal control services in compliance with the rules and regulations established by the New Jersey Department of Health, Office of Veterinary Health.

WHEREAS, the Society is further dedicated to providing animal control services in a humane and progressive manner, including having the goals of reducing the number of animals coming into the shelter through prevention programs (including managed intake and targeted spay/neuter programs), and moving out animals that enter the shelter as quickly as possible (through adoption or other programs).

WHEREAS, the Society is further dedicated to consulting with reputable professional entities in the field of progressive animal sheltering and community services such as the National Animal Care and Control Association, the Association of Feline Practitioners, and other national organizations, intending to implement best practices and procedures of these associations where and when appropriate in the execution of comprehensive community animal services

**WHEREAS**, never before has the public been so interested and involved in the care of animals in their communities. With this comes both the need and opportunity to improve the care provided and address new challenges and financial considerations as the services evolve to meet societal expectations and community needs;

WHEREAS, the Municipality acknowledges and agrees with the importance of such progressive

animal control services and the general goals of reducing the suffering and euthanasia of animals, and serving community members and the welfare of animals;

WHEREAS, the Municipality acknowledges and accepts the Society's values, mission and vision to help animals and their people, and that the Society intends to perform the animal control services in furtherance of those values, mission and vision.

**NOW THEREFORE**, in consideration of the mutual agreements and promises contained in this Agreement, the parties hereby agree as follows:

- 1. <u>Animal Control Services</u>: The Society shall perform the services set forth in Attachment A attached to this Agreement ("Animal Control Services" or the "Services").
- 2. <u>Term:</u> This Agreement shall commence on the 1<sup>st</sup> day of January, 2026 and terminate on the 31<sup>st</sup> day of December, 2026 (the "Term") unless extended in writing by mutual agreement of the Parties.
- 3. <u>Hours</u>: The Society shall provide the Services 24 hours a day, seven days a week, including holidays. Normal business hours shall generally be Monday through Friday between the hours of 9:00 a.m. and 5:00 p.m., excluding holidays.
- 4. <u>Contract Price</u>: The total amount to be paid by the Municipality to the Society for the Services shall be: (Contract Price).
- 5. Payment: The Municipality shall pay the Contract Price in prorated monthly payments of 1/12th of the Contract Price, plus any Additional Services and expenses as stated herein. Payments are due on the first day of each month during the term, provided that the Society has presented the Municipality with an invoice and/or Municipal voucher executed by the appropriate party thirty (30) days prior to the respective monthly payment due date. All unpaid amounts shall be subject to a late fee of two percent (2%) per month. If non-payment extends beyond sixty (60) days, the Society shall have the right to suspend Services until payment is received in full (including interest, costs and expenses). It is expressly understood and agreed that the Society is not obligated to incur any cost, expense or fee as a consequence of the failure of the Municipality to timely and fully remit all payment due hereunder; such cost, expenses and/or fees shall be the sole responsibility of the Municipality and included in payment in full.
- 6. Services beyond the Term: If that Municipality has the Society perform the Services beyond the Term, without the Parties having entered into a superseding written agreement or having extended the term pursuant to Article 2 herein by written agreement, then this Agreement shall be be extended on a month to month basis, for as long as the Society provides such Services, at a New Contract Price that is equal to 1.2 times the original Contract Price set forth in Article 4 herein.
- 7. <u>Indemnification</u>: Both parties (the "Indemnifying Party") shall indemnify, defend and hold the other party (the "Indemnified Party"), its subsidiaries, affiliates, divisions, and their respective directors, officers, employees, shareholders, agents, representatives, successors and assigns

harmless from and against any and all losses, liabilities, claims, liens, demands, damages, causes of action, fines, penalties, costs and expenses ("Losses") arising from the negligence, gross negligence or willful misconduct of the Indemnifying Party or its subsidiaries, affiliates, divisions, and their respective directors, officers, employees, shareholders, agents, representatives, successors and assigns; provided, however, in no event will the Indemnifying Party be responsible for any such Losses caused by Indemnified Party or its subsidiaries, affiliates, divisions, and their respective directors, officers, employees, shareholders, agents, representatives, successors and assigns.

- 8. <u>Independent Contractor</u>: The Society is and shall remain an independent contractor in its relationship with the Municipality. This Agreement shall not render the Society an employee, partner, or joint venturer with the Municipality for any purpose.
- 9. <u>Entire agreement</u>: This Agreement sets forth the entire agreement and understanding between the parties relating to the subject matter herein and supersedes all prior discussions and all previous agreements.
- 10. Governing Law; Consent to Personal Jurisdiction: THIS AGREEMENT SHALL BE GOVERNED BY THE LAWS OF THE STATE OF NEW JERSEY WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES. THE PARTIES EXPRESSLY CONSENT TO PERSONAL JURISDICTION, WHICH SHALL BE EXCLUSIVE, IN THE STATE COURTS OF NEW JERSEY FOR ANY LAWSUIT ARISING OUT OF OR RELATED TO THIS AGREEMENT.
- 11. <u>Severability</u>: If one or more of the provisions in this Agreement are deemed void by law, then the remaining provisions shall continue in effect.
- 12. <u>Attorney Fees</u>: In the event that this Agreement becomes subject to litigation between the parties, the parties agree that the prevailing party shall be entitled to an award of attorney's fees, costs and the prevailing statutory interest from the other party.
- 13. <u>Effective Date</u>: This Agreement shall be effective on the date set forth on page one of this Agreement. The document may be signed in counterparts, and a faxed or electronic signature shall be as effective as an original.

#### ATTACHMENT A

### **Animal Control Services Defined:**

For purposes of this Agreement, Animal Control Services are defined as: the rescue, recovery and care of injured animals, trapped animals, sick animals, animals whose lives are endangered and animals that present a danger to humans or other animals, including those who have bitten humans or other animals.

Except as otherwise provided herein, the Society shall bear the costs and expenses incurred by the Society in the maintenance of its custodial facilities and vehicles used by the Society's Animal Control Officers.

The Animal Control Services shall be performed by a certified Animal Control Officer employed by the Society. It is expressly understood and agreed that the Animal Control Officer is not a law enforcement officer and shall not put his or her life in peril, and accordingly, in certain situations, the Animal Control Officer may request a humane law enforcement officer and/or police officer be present before the Animal Control Officer will respond.

### Animal Control Services are subject to the following terms and conditions:

- 1. The Society shall use reasonable efforts to impound any stray, abandoned or unlicensed dog or cat running at large on property within the Municipality.
  - a. For any animal impounded as a stray, abandoned or unlicensed dog or cat running at large, a person may redeem his or her animal from the Society by: (a) providing proof of the person's identity that satisfies the state statute; (2) proof of ownership of the animal, and (c) payment to the Society of the Redemption Fee and Boarding Fee as set forth below.
    - i. Redemption Fee: If a person redeems the animal during regular business hours (Monday through Friday, 9:00 a.m. until 5:00 p.m.) the redemption sum shall be \$95.00 and at all other times the Redemption Fee shall be \$125.00
    - ii. Boarding Fee: The person shall be responsible for paying the Society a Boarding Fee for the for each day the animal has been impounded as stated below:
      - 1. For the first seven days of impoundment: \$4.00 per day per state statute (or such other amount per day as the state statute may be amended); and
      - 2. Thereafter, **\$20.00** per day (the "Society's Regular Boarding Rate").
  - b. For any animal impounded as a stray, abandoned or unlicensed dog or cat running at large, if the statutory seven-day hold period expires without an owner redeeming the animal, the Society shall have the authority to put the animal up for adoption, if possible, or humanely euthanize the animal at the sole discretion of

the Society. Community cats within a designated Trap Neuter Vaccinate Release ("TNVR") or Spay Neuter Release ("SNR") program, as outlined in Section 6 below, shall be considered on the property of the caretaker or owner, and therefore considered managed and subject to clinical services in the administration of that program, and not stray.

- 2. For any animal impounded or boarded pursuant: (a) to a municipal bite hold; or (2) a dangerous dog or potentially dangerous dog filing, court directive to impound such animal, or order or request from the Municipality or health department, then the Municipality shall pay the Society the Society's Regular Boarding Rate, plus veterinary medical costs and other costs incurred by the Society to impound such animal, which additional boarding fees shall be paid monthly by the Municipality to the Society. After sixty (60) days, it shall be the responsibility of the Municipality to find alternate impoundment or sheltering for any such animal. For reasons that include capacity issues and the health of the animal and costs involved, the Society shall not be required to continue to hold animals animals subject to this Article beyond sixty (60) days. For avoidance of doubt, the Municipality shall pay to the Society on a monthly basis all the Society's fees and costs for impoundment of such animal, and the Municipality shall be the entity responsible for seeking a court order for reimbursement of such fees and costs from the animal's owner.
- 3. For any animal impounded subject to an animal cruelty hold during an animal cruelty prosecution, or other alleged criminal matter involving its owner:
  - a. The Municipality shall pay the Society the Society's Regular Boarding Rate, plus veterinary medical costs and other costs incurred by the Society to impound such animal, which additional boarding fees shall be paid monthly by the Municipality to the Society. The Society shall not be required to continue to impound an animal if the Municipality fails to pay. For avoidance of doubt, the Municipality shall pay to the Society on a monthly basis all the Society's fees and costs for impoundment of such animal, and the Municipality shall be the entity responsible for seeking a court order for reimbursement of such fees and costs from the animal's owner.
    - i. NJ Cost of Animal Care Law Petition Filing Within 20 Days of Impound: Pursuant to N.J.S.A. 4:22-46.3, the prosecutor may file a civil cost of care petition with the civil division of the Superior Court within 20 days of impoundment of animals subject to an animal cruelty hold in order to allow for a hearing to be scheduled under the applicable law to determine reasonable costs the owner should pay. For animals impounded to the Society animal cruelty charges, the Municipality agrees to have its municipal attorney work with the prosecutor to ensure a timely submission and prosecution of the petition in Court. The Society will provide the Municipality with relevant information for the Municipality to use in the petition.
  - b. Foster hold homes for court hold animals: As allowable by state law, The Society

reserves its right to utilize foster homes external of the animal shelter for an animal subject to a court hold to an approved foster home arrangement approved by The Society. Recognizing that cruelty cases often take a lengthy time to adjudicate, and that shelters are only very short-term temporary housing for animals, foster homes allow for the shelter to alleviate space concerns and provide a more stress-free placement for the animal.

- 4. For all impoundments, the Municipality shall: (a) specify to the Society in writing the type and basis of the impoundment; and (b) provide to the Society all paperwork required by the Society for such impoundment.
- 5. If the Municipality fails to pay or continue to pay for impoundment or housing of any animal, the Society shall have sole discretion as to the disposition of such animal, including but not limited offering the animal for adoption, placing the animal in foster care, transferring the animal to a rescue or other similar facility, or euthanizing the animal.
- 6. The Society's animal control shall report to the Municipality any owned animal without a current license and/or rabies certificate. The owner shall have seven (7) days to register the animal for a license and if the owner fails the animal control officer shall issue a summons, if the Municipality has supplied the animal control officer with a Summons book.
- 7. The Society may, at the request of a municipal resident who is the owner of an unwanted animal, render assistance in delivery of said animal to an appropriate humane shelter, including a shelter maintained by the Society. However, such assistance is not within the scope of Animal Control Services under this Agreement. The owner shall be responsible for payment to the Society of the costs and expenses of such assistance.
- 8. Community Cat Management: The Society, in accordance with best practices of the National Animal Care and Control Association (the "NACCA"), recognizes that the indiscriminate pick up or admission into the shelter of healthy, free-roaming cats with no signs of ownership, regardless of temperament, for any purpose other than Trap, Neuter, Vaccinate, Return (TNVR) or Shelter Neuter and Return (SNR) programs, fails to serve commonly held goals of community animal management and protection programs and, as such, is a misuse of time, municipal funds, and a violation of the Society's mission. The Society shall not trap or pick up healthy unowned, unsocialized free-roaming cats, known as "community cats." In those cases, the Society shall work with the Municipality's TNVR Program to trap, spay/neuter, vaccinate and release the cat back to the area they were trapped as "Additional Services." Such Additional Services shall incur a charge of \$100 per cat. If the Society cannot collect this fee from the TNVR Program, the Municipality shall be responsible for the Additional Services fees. If there is no municipal sanctioned TNVR program, the Society reserves the right to provide proper care and release of the community cat through its own SNR program within the contracted municipality in accordance with public health guidelines and best practices of the National Animal Care and Control Association. By virtue of engaging the Society for animal services, the Municipality acknowledges, accepts, and endorses Trap-Neuter-Vaccinate-Return (TNVR), a process by which community stakeholders work together to humanely reduce outdoor free roaming cat populations by trapping the animals, providing clinical services of sterilization, vaccination against rabies,

ear tipping, and return to the place within the Municipality where the animals were originally located. Should the Municipality not have a community cat ordinance in local code at the time of engaging the Society with this agreement, the Municipality agrees to work with the Society to enact a comprehensive community cat management ordinance within six months of signing this agreement and shall not hinder any efforts of the Society to carry out the best practices of the NACCA through TNVR practices.

- 9. As per N.J.S.A. 4:19-32, the Society shall inspect the enclosure and the owner's property of a potentially dangerous dog, at least monthly, to determine continuing compliance with paragraphs (2) and (3) of subsection A of N.J.S.A. 4:19-24.8. The Society shall submit the inspection reports to the Municipality monthly.
- 10. The Society shall not provide census or canvassing services for license compliance within the Municipality. Under N.J.A.C. 4:19-15.15, the Municipality must appoint a party or agency to canvas for owned animals.
- 11. If an Animal Control Officer has determined that an animal has bitten a human and needs to be quarantined for ten (10) days due to risk of rabies, the animal shall be quarantined in the home of the owner or at the Society. If the animal is quarantined at the Society, the Municipality shall pay the Society the Society's Regular Boarding Rate and shall pay such amount monthly. If the animal's owner picks up the animal from the Society at the end of the ten-day quarantine period, the Society shall require the owner to pay the Society's Regular Boarding Rate and any amounts paid by the owner shall not be invoiced by the Society to the Municipality
- 12. In case of potential rabies exposure, the cost of transportation of the head of an animal suspected of rabies to the State Department of Health shall be borne by the owner of the animal and, if no owner is known, shall be borne by the Society, under the condition that the animal expired on the premises before the ten (10) day quarantine period referred to above.
  - Removal of an animal, including wildlife, within the living space, inside the walls or ceiling of a home, apartment building or garage is not within the definition of Animal Control Services that the Society is to provide under this Agreement. The Society may respond to those calls and the calls shall be governed as follows:
    - a. For calls from residents of the Municipality wishing for assistance with wildlife complaints or other wild animal related issues which do not involve sick or injured animals and do not pose any immediate threats to their health and safety, the Society may respond to those calls at its discretion or refer the resident to an alternate agency. Should the Society respond, the owner of the premises shall be charged \$100.00 per hour during regular business hours and \$125.00 per hour after standard business hours for humane removal, exclusion, and abatement services.

- b. Communication from the Municipality to residents: The Municipality agrees to make an effort to inform residents that they may engage with the Society for assistance from The Society with nuisance wildlife concerns at their own cost.
- c. Calls originating from officials with The Municipality: For assistance with any wildlife matters requested but <u>not</u> already required by state law within the definition of Animal Services, the Municipality will be assessed the same fee structure as stipulated for residents above. There shall be no additional charge for responding to injured wildlife, and the Municipality agrees to assist the Society in contacting the New Jersey Division of Fish and Wildlife should their assistance be required in certain wildlife situations necessitating their involvement.
- 13. There shall be no additional charge for trapping or picking up bats or injured wildlife.

### **Exclusions:**

- 1. Marine mammals shall be specifically excluded from the definition of Animal Control Services under this Agreement.
- 2. Removal of roadkill or other dead animals shall be specifically excluded from the definition of Animal Control Services under this Agreement. With regard to deer, the Society shall not be responsible for handling deer carcasses, provided however, that the Society shall retrieve infirm, injured deer and orphaned fawns. Removal of roadkill or other dead animals is the responsibility of the local or county Department of Public Works, not the responsibility of The Society. However, it is best practice for deceased domestic companion animals (i.e.: dogs, cats, rabbits) to be reported to the Society so an animal services officer may scan the animal for a microchip and make attempts to determine ownership of said deceased domestic companion animal. Should the Society determine the deceased animal's owner, the Society shall make attempts to contact the owner and return the animal. If no owner can be determined, the Society may remove the animal or make a request of DPW to remove the animal.
- 3. The Society shall not trap or rescue Canada Geese, unless same need veterinary care. The Municipality shall not engage in any lethal management practice regarding Canada Geese during the pendency of this Agreement. Should the Municipality have concerns regarding Canada Geese, it agrees to work with the Society to secure non-lethal approaches to managing Canada Geese. Engaging in lethal culling of Canada Geese is a violation of humane management practices and constitutes a breach of this contract.
- 4. The Society shall not pick up live rats, mice, moles or voles or any other small rodents.
- 5. According to the best practices reflected on the NJ Department of Health's website, capture of nuisance wildlife (i.e., healthy appearing raccoons not threatening humans, squirrels in attics, groundhogs burrowing in yards, etc.) is NOT required under statute for municipal animal control to provide, and the Society shall not be required to pick up such animals. In general, wildlife nuisance issues are addressed by the New Jersey Department of

Environmental Protection, Division of Fish and Wildlife. ACOs can help educate residents on how to abate common wildlife nuisances and refer residents to pest control services, wildlife rehabilitators and other agencies that can assist residents if ACOs are not authorized by their supervisors to provide these services.

6. Trapped healthy wild animals that do not pose a threat or safety risk to the public may be released at or near the area of capture or if necessary, at another appropriate location at the sole discretion of the Society in accordance with standard rules and regulations of the industry.

### **Emergencies:**

Upon a request from the Municipality, the Society shall respond to an animal control emergency as defined herein. Emergency treatment shall be provided to ill or injured animals as required by State law and regulation. The Society reserves the right, at its sole discretion, to determine if the animal requires transportation to an emergency clinic on nights, weekends or holidays when our own veterinarians are not available.

The costs of emergency treatment shall be charged to the animal's owner where the owner is known. If the animal's owner is unknown, or if the owner fails to pay the costs of emergency treatment, said costs shall be paid to the Society by the Municipality.

Response time to an emergency shall be no longer than one (1) hour during normal business hours of operation. All calls to the Society for Animal Control Services after normal business hours must be received through the Police Department or Health Department of the Municipality. Residents shall not be instructed by the Municipality to contact the Society or Animal Control Officers directly after normal business hours.

### NJ Open Public Records Act (OPRA):

The Municipality shall handle all Open Public Records Act ("OPRA") requests and shall have the obligation to retain any and all paperwork received from the Society for OPRA fulfillment and compliance. The Society, as a non-profit, private independent contractor is not subject to OPRA (the Open Public Records Act) and the Society shall not be required to produce documents to the Municipality for any OPRA request. If the Society receives an OPRA request, it shall promptly forward it to the Municipality for the Municipality to handle.

### **Humane Traps**:

Humane traps are available to rent from the Society (depending on the season and availability of traps) with a deposit of \$65.00 and a fee of \$4.28 per day, which shall be deducted from the deposit. Humane dog traps shall also be available (depending upon the season and availability of traps) with a deposit of \$150.00 and a fee of \$10.70 per day, which shall be deducted from the deposit. The Society reserves the right to establish conditions for humanely setting traps. Once a trap is set, it is the responsibility of the property owner/business/landlord or tenant to monitor the trap and inform the Society *immediately* when pick up is needed. (SEE TRAP RENTAL AGREEMENT/RULES & REGULATIONS ATTACHED).
