### Aurthur Kobitz, 327 Trinty Place

• Council Member Feuerstein wasn't here then, but in the past, the town managed part-time positions. In 1998, under the Faulkner Act, we had a part-time Business Administrator. Later, under Mayor Angela, even the CFO was part-time. Public Works was once run by someone working just six hours a week. These roles saved money. Not trying to see anyone lose their job, it's not personal—but without any cuts, my taxes will go up \$400 a quarter. That's just not affordable.

### Rayba Watson, 830 Jerome Ave.

- My first question is for the Councilman. He mentioned that he sent a letter to the state requesting an extension because he received the budget on the 25th essentially at the last minute. So, my question is: why wasn't that email sent on Thursday or Friday, the 26th or 27th? Why wait until the morning of the meeting to send it? That timing seems to be too last-minute.
- My second question is about the budget process. From what I understand, the administration is supposed to introduce the budget, and then the council reviews it and suggests cuts. I've heard both Councilwoman Garretson and Councilwoman Hyatt say they had ideas on where cuts could be made. So my question is: aren't we now at the point where the council should be reviewing the budget and making recommendations? Even if the administration isn't actively sitting down with the finance team, shouldn't this be the phase where you begin that dialogue and propose changes.
- We've been dealing with late budgets quite often. I heard that council members get fined for voting no on the budget introduction. Are there any penalties for the administration when they introduce the budget late? Who is responsible for enforcing those penalties?
- The last question is about the proposed 13.7% increase. Since we're already in the third quarter, is that increase spread out over the remaining quarters, or does it apply to the entire year? I hope this number will be reduced and that we move away from such a high increase

### Aldeana Mitchell, 1431 Maple Ave;

- I just want to clarify, introducing the budget doesn't mean you're approving it, correct?
- The administration keeps sending the budget late, which puts pressure on the council to rush decisions. That's not fair to you or the taxpayers. If we get fined, it's because the administration waited too long, not the council. You can't fix a year's worth of financial issues in just a couple of weeks. Every year, we spend money that hasn't even been budgeted. Taxpayers shouldn't be responsible for that.

### Marisbel West, 36 Hurden St.

- I reviewed the budget, and it looks like the bulk of the increase is due to rising health insurance costs which are directly tied to personnel.
- I heard someone mention that, years ago, we had more part-time positions. Has Hillside ever conducted a manpower study to determine whether we're employing the right number of staff for the size and needs of our departments and the township?

### Barbara Rowen, 950 Westminster Ave.

- Thank you to the council, especially David Feuerstein, for your hard work on this budget. The last-minute delivery from the administration and limited review time is unacceptable.
- We need a responsible budget. Many seniors in town can't afford this increase, and I'm already paying over \$20,000 a year in taxes and won't pay more.
- Special thanks to Councilwoman Andrea Hyatt for her deep understanding of the budget. I'll encourage more neighbors to join the next meeting to share their concerns.

### Orlando Kenyon, 1197 S. State St.

• I have a view of the Central Avenue Pool; I understand the administration is working hard on its renovation. Could you please provide an update on its expected opening date? Is it still scheduled to open this year?

### Daniel Fleisher, 211 Surrey Road

- First, why isn't the mayor held accountable like council members for submitting the budget late? Could the township pass an ordinance to fine the mayor if the budget is delayed, to prevent last-minute issues?
- Second, last year we had a 7% tax increase due to using up the town's surplus after years of deficits. With a 13.75% proposed increase this year, even with cuts, taxes will rise. Please do a deep review of our finances to find out when and why we started running at a loss and fix it. If a smaller increase passes instead, will we face steady increases every year? We need a balanced budget to keep taxes stable
