**WHEREAS**, in accordance with the provision of N.J.S.A.10:4-18, at least once a year, within seven days following its annual reorganization meeting, the Township Council is obligated to provide "adequate notice", as defined in N. J. S. A. 10:4-8(d), of the schedule of the regular meetings of the Township Council to be held during the succeeding year; and

**WHEREAS**, the Township Council desires to establish a meeting schedule for the year (January 1, 2026, through December 31, 2026), as required by the New Jersey Open Public Meetings Act.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Hillside:

During the period of January 1, 2026, through December 31, 2026, unless otherwise indicated below\*, the Township Council shall have (1) Annual Reorganization Meeting (1) Caucus Meeting per month and (1) Caucus-Regular Meeting per month. Unless otherwise notified, all Caucus Meetings, Regular Meetings, and the Reorganization Meeting of the Township Council shall be held at 6:30 p.m. at the Township Municipal Building, 1409 Liberty Avenue (Liberty and Hillside Avenues), Hillside, NJ 07205.
